Chief Justices Leadership Forum

Tamaki Makaurau February 2025



Chief Justices from our 15 Pacific partner countries, Australia, and Aotearoa New Zealand gathered in Tāmaki Makaurau Auckland for the annual Chief Justices Leadership Forum on 14 February. Thirty-two Chief Justices, observers and guest speakers were welcomed to the full day programme, which started with a mihi whakatau by Chief Justice of Niue, Craig Coxhead, and words of welcome from Chief Justice of Aotearoa New Zealand and Tokelau, Rt Hon Dame Helen Winkelmann.

PJSP Komiti Chair, Justice Gerard van Bohemen led the sessions, where discussions continued around shared priorities the Justices had agreed at the CJLF in Samoa in 2024. Other sessions focused on PJSP's Strategy, the Pacific Judicial Leadership project, and the Pacific Judicial Digital Strategy. The Federal Court of Australia's International Program team also delivered a session on their plans for the Pacific judiciary.

Samoan judiciary welcomed to Tamaki Makaurau for Judicial Exchange March 2025

Eleven members of the Samoan judiciary and court registry staff were welcomed to Tāmaki Makaurau in March for the biennial Judicial Exchange between judges from Aotearoa New Zealand and judges from Samoa. This year's program was facilitated by the Chief Justice of New Zealand and Tokelau, Rt Hon Dame Helen Winkelmann and Chief District Court Judge of New Zealand Judge Heemi Taumaunu with other hosts Judge Jacquelyn Moran (Principal Family Court Judge New Zealand), Judge Ida Malosi (Principal Youth Court Judge New Zealand), Marcus Akuhata-Brown (Pou Whakatere – Deputy Secretary, Ministry of Justice), and Reuben Lewthwaite (Director, Te Whare - Chief District Court Judges Chambers). The 2025 programme featured a trip to Te Oohaakii Marae near Huntly, and presentations by leaders and members of the Māori Parliament House of Waikato. The four-day programme facilitated many enriching conversations between judicial officers about the nature of their work.

The inaugural New Zealand Samoa Judicial Exchange took place in Apia, Samoa in 2023. The Exchange is also a great example of the values underpinning the Treaty of Friendship signed by our two countries in 1962.

The Handbook was first published in 2008. The work updating and translating the Handbook across 2023 and 2024 was undertaken by the Handbook Editorial Committee led by former Samoan judge and PJSP trainer Tagaloa Enoka Puni, and included Professor Tony Angelo, Law Commissioner Safiti Gaualofa, Aukusitino Vitale, and Apolima Tamoa. 

Spotlight on Tonga

PJSP works in partnership with the judiciary, Magistrates, lay judicial staff, legal advocates, and court staff of Tonga, providing on going technical support for Tonga's court management systems and court performance. PJSP also provides scholarships for the University of South Pacific's Certificate and Diploma of Justice program, and supports

regular training activities in the Human Rights, Access to Justice, Litigation Skills, Family Protection Orders and Continuing Legal Education Workshops.





Family Protection Orders Training, March 2025

Senior Magistrate Peti Langi, the residing Magistrate from the Court of Vava'u Tonga, conducted two 'Family Protection Orders' training/workshops, the first in Nukualofa Tongatapu and the second in Vava'u. Altogether 27 participants attended the training. Participants from the Family Legal Aid Centre (FPLAC), Court staff, the Police Domestic Violence Unit (DVU), and the Tonga Family Courts learned the meanings of domestic violence and domestic relationship. The workshop went over the different types of protection orders available under the Family Protection Act and the key elements required to issue a Protection Order.

Participants discussed challenges they faced when completing Protection Order applications and options and tools to consider in these circumstances. This training was designed to reinforce the availability of Protection Orders and its effect as well as expanding the reach within the advocacy community in Nukualofa.
